## Baker Boyd, Lieutenant, Co. C, 7th KY Mounted Infantry, C.S.A.

- 1837 April 9: Boyd was born in Kentucky to William and Jane Boyd.
- 1850 August 9: The U.S. Census enumerated in Hancock County, KY showed Boyd lived with his father on his farm along with his step-mother Cynthia, his brother Henry C. Boyd, and a man named James S. Yenland.
- 1861 May 10: Enlisted in the Confederate Army. Company Muster Roll. Denoted Camp Cheatham, near Cedar Hill, TN as Boyd's point of origin.
- 1862 January February: Company Muster Roll. Denoted Boyd as Present.
  - November December: Company Muster Roll. Denoted Boyd as Present.
- 1863 March 11: Company Muster Roll. Denoted Boyd as Present. Remarks "Promoted to Bre 2nd Lieut. Jany. 1, 1863."
  - June 30: Company Muster Roll. Denoted Boyd as Present.
  - July August: Company Muster Roll. Denoted Boyd as Present.
  - September 12: Company Muster Roll. Denoted Boyd as Absent. Remarks "Detached on Conscript service."
  - October December: Company Muster Roll. Denoted Boyd as Absent. Remarks "Detached on Conscript service Sept. 12, 1863."
- April 11: Boyd appeared on a List of officers of the 7th Regiment Kentucky Cavalry, near Tupelo, MS. Remarked "Elected March 1, 1864."
  - May June: Company Muster Roll. Denoted Boyd as Present.
  - July 13: Boyd appeared on a Report of killed or wounded in the Battle of Harrisburg, MS.
  - November 30: Wounded at the Battle of Franklin.

December 17: Boyd appeared on a Roll of Prisoners that showed he was captured by U.S. troops near Franklin. He was taken to Nashville, TN.

December 21: Boyd appeared on a Roll of Prisoners that showed he was taken to the Military Prison near Louisville, KY, before being immediately sent to Johnson's Island, near Sandusky, OH.

December 23: Boyd appeared on a Roll of Prisoners that showed he arrived at Johnson's Island, near Sandusky, OH. He remained here for the rest of the War.

- June 16: Boyd appeared on a Roll of Prisoners that showed he gave the Oath of Allegiance and was released from prison. His place of residence was given as Bowling Green, KY. His age was given as 27 years old.
- 1868 October 1: Boyd married a woman named Cecilia V. Barion.
- 1870 July 5: The U.S. Census enumerated in Daviess County, KY showed Boyd worked as a lawyer while he lived with his wife, an African American domestic servant named Hannah Boyd, and Hannah's daughter Dina.
- 1886 July 13: Boyd died at the age of 51. He was buried in Rosehill Elmwood Cemetery in Owensboro, Daviess County, KY.
