William M. Mason, Private, Co. D, 31 IN Infantry, US

- 1846 May 11: Mason was born in Sullivan County, IN to James M. and Elizabeth Albright Mason.
- 1850 September 6: The U.S. Federal Census enumerated in Gill, Sullivan County, IN showed four-year-old Mason living with his parents and brother (or nephew), Anthony. His father, was a farmer.
- 1855 January 24: Father, James, died when Mason was only eight years old.
- 1857 December 25: On Christmas day, Mason's mother Elizabeth died, leaving him orphaned.
- 1860 July 14: The U.S. Federal Census enumerated in Gill, Sullivan County, IN showed fourteen year old William living with George and Margaret Davis.
- 1863 July 29: Enlisted in U.S. Army and mustered into Co. F, 115 IN Infantry. He had just turned seventeen years old.

"William M. lived in Sullivan county till seventeen years of age, when he enlisted in the Civil war, June 29, 1863,[sic] in Company F, One Hundred and Fifteenth Ind. V.I, and was in the siege of Nashville, also at Ball's Gap. He was discharged February 25, 1864, at Indianapolis, and March 20, 1864, he re-enlisted, this time in Company D, Thirty first Ind. V.I., and was discharged in December, 1865. He was in the Battle of Resaca, also through the Atlanta campaign, and in the battles of Ashville, N.C., Franklin, Tenn., as well as the two days' fight at Nashville."¹

1864 February 25: Discharged from the 115 IN and took a months furlough before reenlisting as a veteran in the 31 IN Infantry, Co. D.

- 1870 July 13: The U.S. Federal Census enumerated in Terre Haute, Vigo County, IN showed William, a stationary engineering, boarding with an Archer family.

- 1874 April 2: Married Gertrude Conover in Vigo County, IN.
- 1880 June 28: The U.S. Federal Census enumerated in Terre Haute, Vigo County, IN showed William, a well digger, and Gertrude living with their two young children.
- 1888 October 8: Mason applied for and was granted a military pension for his service during the Civil War. His pension was \$14.00 per month.^₄
