
## Newton Currie, Lieutenant, Co. A, 6 TN Infantry, CSA


- 1837 January 15: Born to Washington and Anna Walker Currie in Haywood County, Tennessee.
- 1850 October 28: The U.S. Federal Census enumerated in Haywood County, TN showed Newton lived with his parents and siblings. His father's occupation was listed as farmer. The Currie family owned six slaves.
- 1852 January 1: Anna Currie, Newton's mother, died at the age of thirty-five. Newton was fourteen years old when he lost his mother.
- 1853 September 6: Washington, Newton's father, married Mary Taylor in Madison County, TN.
- July 18: The U.S. Federal Census enumerated in Haywood County, TN showed Newton lived with his dad, step mother, and siblings. He and his father's occupation was listed as farmer.
  - July 20: The U.S Federal Census- Slave Schedule showed Washington, Newton's father, owned twelve slaves.
- 1861 May 21: Enlisted in Co. A, 6 Tennessee Infantry as a Private in Jackson, TN.
- 1862 January to December: Company Muster Rolls: Present
- 1863 January to December: Company Muster Rolls: Present
- 1864 January to April: Company Muster Rolls: Present
  - November 30: Newton fought at the Battle of Franklin. According to his pension records, he was severely wounded in the foot and given a twenty day furlough.
- 1865 May 31: Paroled in Memphis, TN.
- 1866 August 8: Married Malvina Talley in Lauderdale County, TN.
- 1870 July 13: The U.S. Federal Census enumerated in Haywood County, TN showed Newton lived with his wife and two young children, John, 3, Newton, 6 months. His occupation was listed as a farmer.

- 1874 August 18: Newton was a delegate of Haywood County for the State Convention.
- 1878 August 2: He attended a reunion for the 6 Infantry Regiment in Jackson, TN.



1880 June 5: The U.S. Federal Census enumerated in Haywood County, TN showed Newton lived with his wife and six children. His occupation was listed as a farmer.

- 1890 January 1: Tennessee, U.S., Enumeration of Make Voters, showed Newton, 54, lived in Haywood County, TN.
- 1898 Newton's daughter Annie May died.
- 1900 June 1: The U.S. Federal Census enumerated in Haywood County, TN showed Newton lived with his wife and eight daughters. His occupation was listed as a farmer.
- 1908 February 1: Died in Brownsville, TN. Buried at Oakwood Cemetery in Haywood County, TN.



- 1917 Malvinia was dropped from the pension roll stating that she could live on her own means without a pension.
- 1921 Malvinia was still fighting to receive her husband's pension.
