## Orson G. Reeve, Private, Co. G, 8 IA Cavalry, US

1846 July 4: Born to James and Adeline Riggs Reeve in Ashtabula County, OH.

- 1850 August 8: The U.S. Federal Censusenumerated in Trumbull, Ashtabula County, OH showed four-year-old Orson living with his parents and siblings. His father, James, was a farmer.
- 1853 September: The Reeves family migrated from Ohio to Iowa. *"I can well remember the gradual progress of the white man westward. Altho only a small boy of seven years, I can clearly recall when our family traveled westward by rail to Rockford, Ill., started in a covered wagon on the long trek to Franklin county. I can also still recall the beauties of Iowa's virgin prairie and its patches of forest as we passed along the route. We arrived in Franklin county Sept. 15, 1853, and there were then three cabins standing. All settlers assisted my father in building a cabin for us and three days after our arrival, we had a home. Since that time, Franklin county has always been my home."*<sup>1</sup>

Reeve's father served multiple terms as a judge and treasurer of Franklin County, IA.

- 1860 June 19: The U.S. Federal Census enumerated in Reeve, Franklin County, IA showed 13-year-old Orson living with his parents and siblings.
- 1861 September 18: Brother, Fernando, enlisted in the U.S. Army and mustered into 9th IA Infantry.
- 1862 August 14: At 47-years old Reeve's father, James, was commissioned as an officer in Co. H, 32nd IA Infantry. *"When the South rebelled against the old flag, and the country was in peril, Mr. Reeve [James] raised a company, of which he was made captain.*"<sup>2</sup>

June 24: Father, James, died of congestive fever at Fort Pillow, TN.

1864 March 14: Brother, Fernando, was captured in Alabama and sent to Andersonville.

September 21: Brother Fernando died at Andersonville, GA of debilitas.


November 30: Fought at the Battle of Franklin.

- 1865 August 13: Mustered out of the U.S. Army in Macon, GA.
- 1870 August 3: The U.S. Federal Census enumerated in Reeve, Franklin County, IA showed Orson, a farm laborer, living with his mother and siblings.


## 1872-3 Married Sarah Parks.

## Orson G. Reeve, 86. Will Be Buried Thursday.

HAMPTON, May 4 .- Orson G. Reeve, 86, oldest settler of Franklin county and Civil war veteran, died at 6 o'clock last evening from heart disease, following an illness of three weeks. Previous to his last illness, he had been quite active.

Funeral services will be held at 2 o'clock tomorrow afternoon at the nome in charge of the Rev. H. L. Michael, pastor of the Congregational church.

Mr. Reeve was born in Ashtahula county, Ohio, July 4, 1846. He came to Franklin county with his parents when he was 7 years of age. His parents settled in Reeve township which was named after them. A town which developed there was Mayfield, for a time the county seat of Franklin county.

On June 15, 1863, he enlisted in Company G. eighth Iowa cavalry. with which he served two years and three months. He was discharged children John Reeve, Macy, Nebr., Aug 30 1865. Mr. Reeve served in Sherman's army until it reached Atlanta and then was sent to Nash-

For 66 years Mr. Reeve was an Odd Fellow and was the oldest Odd Fellow in Franklin county in point of service. He was also a member of the Rebekah lodge and the G. A. R.
