


Edward Cary Walthall, General, Commanding Division, CS

1831 April 4: Born in Richmond, VA to Barrett and Sarah Walthall.

"He was educated at Holly Springs, Miss., studied law, was admitted to the bar in 1852 and practised at Coffeeville, Miss. In 1856 he was elected district attorney of the 10th judicial district of Mississippi, and he was re-elected in 1859, but resigned in 1861 and entered the Confederate Army as a lieutenant in the 15th Mississippi infantry."

August 16: Married Sophia A. Bridgers in Shelby County, TN.

November 26: Walthall's new wife Sophia died.

1860 February 1: Married Mary L. Jones in Mecklenburg County, VA.

MATRIMONIAL.—Edward C. Walthall, Esq, District Attorney of the Grenada Judicial Circuit, in this State, was married on the 1st inst., in Mecklenberg county, Virginia, to Miss Mary L. Jones.

September 13: The U.S. Federal Census enumerated in Yalobusha County, MS showed E.C., an attorney at law, lived with his wife Mary. They owned six slaves.

1861 May 1: Enlisted in the C.S. Army as a Captain. He mustered into Co. H, 15th MS Infantry.

More Volunteers — A volunteer company, numbering seventy five, was organized at Coffeeville last Saturday. F. M. Aldridge was elected Captain, Edward Walthall 1st Lieutenant, and G. Q. Martin 2d Lieutenant. Aldridge is an eminent lawyer, has been a member of the Legislature and of the late State Convention; Walthall is District Attorney and distinguished for talents; Martin has been a member of the Legislature, and is now Probate Judge with a salary of \$1,000. Aldridge and Martin were decided leaders of the Union party.

We learn from the Holly Springs
Herald that Edward C. Walthall has been
elected Lt. Colonel of the 15th Mississippi
Regiment.

1862

"He was promoted to lieutenant-colonel, and commanded the regiment in the battle of Fishing Creek, or Mill Springs, KY, 19 Jan, 1862. Subsequently he became colonel of the 29th Mississippi regiment and he was promoted brigadier, 13 Dec., 1862, and major general, 6 June, 1864. His service was in the western army. At the battle of Mission Ridge, after the National forces had penetrated the Confederate lines, Gen. Walthall, under direction of Gen. Benjamin F. Cheatham, threw his brigade across the ridge and held the advancing troops in check until darkness enabled the Confederates to make their escape."

1864 November 30: Division commander at the Battle of Franklin.

"He commanded the rearguard of General John B. Hood's army after that general's disastrous defeat at Nashville, and protected them from capture by the pursuing forces of General George H. Thomas."

- 1868 Delegate at National Democratic convention.
- 1870 August 26: The U.S. Federal Census enumerated in Yalobusha County, MS E.C. a lawyer living with Mary.
- 1871 January: "Gen. Walthall resumed the practice of law at Grenada, Miss., which he continued until March, 1885."
- 1876 Delegate-at-large at National Democratic convention.
- 1880 June 15: The U.S. Federal Census enumerated in Grenada, Grenada County, MS showed Edward C, a lawyer, and Mary living with their adopted eight-year-old daughter.
 - Delegate-at-large at National Democratic convention.
- 1884 Delegate-at-large at National Democratic convention.
- 1885 March 12: "He was appointed to the U.S. senate as a Democrat to fill the vacancy caused by the resignation of Lucius Q. C. Lamar, took his seat on 12 March, 1885, and was elected by the legislature in January, 1886, for the unexpired term, without opposition. He was unanimously chosen for the term that will end in 1895."

Gen. Edward Walthall, appointed U. S. Senator from Mississippi to succeed Senator Lamar was a Confederate officer, like the man whose seat he takes. The Cincinnati Enquirer thus summarizes his war record: "He entered the Confederate army as Lieutenant of volunteers, and rapidly rose to the rank of Major General. He served under Bragg, Johnson and Hood, and no officer in the army of the Tennessee had a more brilliant record or was more admired or beloved by the soldiers under his command. It has become to be one of the indispensables of Southern Senatorship that the incumbent has worn straps in the Confederate Army. And at Washington their tribe is increasing with every year. Two have just been moved into the ministry; two like them will be sent to the Senate to recruit the ranks.

Senator Edward C. Walthall, of Mississippi, died at his apartments at the Cairo to-day at 5:30 p. m. His death was not unexpected, the end having been foreseen for several days.

Senator Walthall's illness dated from January 'ast, when he contracted a cold. In February he suffered from an attack of bilious fever, and from this he never recovered. His last address in the Senate was made on April 7, when he delivered a eulogy on his colleague, Senator George, in spite of the protests of his physician. The following Saturday he was confined to his bed with a severe attack of typhoid pneumonia which to day resulted fatally.

Edward C. Walthall was born in Richmond, Va., in 1830 He served in the Confederate army during the civil war, rising to the rank of Major General His profession was the law. With the exception of fourteen months, from January. 1894, to March, 1895, Mr. Walthall sat continuously in the Senate since the 12th of March, 1885.
